What is OLEV and how does it work?

The OLEV Workplace Charging Scheme (WCS) is a voucher-based scheme that provides support towards the up-front costs of the purchase and installation of electric vehicle charge points

-Qualifying businesses can claim up to £7,000 off the cost of your EV charging points under the Workplace Charging Scheme (WCS)

-Companies can purchase up to 20 EV charging points at a subsidised cost, with each charging 'socket' having as much as £500 price reduction
